#### **Product Description**

RUSTX – 132 A XR is a semi-viscous grade of rust preventive oil having excellent thixotropic properties and holds well on surfaces that may be super finished or vertically placed.

The product has a high flash point and can be used for protection of Cold Rolled Steel, Engine Components, as well as large equipment where indoor open storages are required.

The VCI action of the oil makes it suitable for spraying within hollow equipment such as boilers, heat exchangers, reactors, storage tanks, pipes etc. The VCI fraction evaporates and reaches hard to reach surfaces

#### **Application Method**

Dipping by far is the best method for establishing an even layer on the component. Other methods may be used such as mist spraying, electrostatic spraying, brushing, automatic conveyor spray or dip process pray. It is important that the complete surface of the component is coated with the rust preventive oil.

Use of gloves while handling the components as well as immediate packaging is important. In case the components carry cutting oils or water from previous processes, dewatering with CL005 is recommended.
